# 1. Summary


This is the monthly publication of the Producer Price Index (PPI) for the month of July 2019.

- ➤ General Producer Price Index increased by 17.25 percent on annual basis
- ➤ Local Producer Price Index increased by 25.48 percent on annual basis
- ➤ Export Producer Price Index decreased by 8.8 percent on annual basis
- ➤ General Producer Price Index increased by 2.84 percent on monthly basis
- ➤ Local Producer Price Index increased by 3.22 percent on monthly basis
- Export Producer Price Index increased by 0.21 percent on monthly basis

### 2. Introduction

The Producer Price Index (PPI) measures the average change over time in prices received by domestic producers for the production of their goods and services. PPI for Rwanda is published on a monthly basis.

It presents price changes for all combined products, products for local sales and that for exports. It covers a sample of 114 establishments and 402 products spread countrywide, both

in Kigali City and in rural areas.

PPI survey is conducted jointly with the National Bank of Rwanda. It now covers mining, manufacturing and energy.

### 3. General Producer Price Index

Table 2 below presents the percentage changes on monthly and annual basis.

General PPI increased by 17.25 percent in July 2019 compared to the same month of 2018. This is mainly due to an increase of 90.59 percent in prices of 'Water supply activities', 32.73 percent in prices of 'Electricity & gas supply activities' and 5.38 percent in the prices of manufacturing activities.

The general PPI increased by 2.84 percent when compared to June 2019. This was mainly due to an increase of 5.5 percent in prices of manufacturing activities.

# 4. Local Producer Price Index

The table 3 below presents the percentage changes on monthly and annual basis.

Local PPI increased by 25.48 percent in July 2019 compared to the same month of 2018. This was mainly due to an increase of 90.59 percent in prices of water supply activities, 32.73 percent in prices of 'electricity and gas activities', and 7.43 percent in the prices of manufacturing activities.

The local PPI increased by 3.22 percent when compared to June 2019. This was mainly due to an increase of 5.77 percent in the prices of manufacturing activities.

# 5. Export Producer Price Index

The table below presents the index and the percentage changes on monthly and annual basis.

Export PPI decreased by 8.80 percent in July 2019 compared to the same month of 2018. This was due to a general decrease in prices most of export products.

Export PPI increased by 0.21 percent compared to June 2019 due to an increase of 18.23 percent of price of coffee and 2.23 percent of price of other manufactured chemical products.

### 6. Technical note on PPI

The Producer Price Index (PPI) measures the average change over time in the prices received by domestic producers of goods and services—goods and services which are output of production or enter in the production process.

NISR publishes PPI data for Mining, Manufacturing and Energy, and it will continue to be published monthly, about 4 weeks following the month under review.

The establishments are classified according to ISIC rev. 4; and the classification is determined by their main output.

The weights used in the PPI for Rwanda refer to the value of output (turnover without taxes) of establishments as reported in the 2011 Manpower survey collecting data for the year 2010, which constitutes the reference base period for the PPI calculation (December 2010). We plan to rebase the PPI using the weights as reported in establishment census 2017.

The point of pricing is the establishment. The price is the selling price received by the producer for the selected product as it leaves the factory gate. In general, prices are collected each month from the selected establishment by considering the mid-point of each month of the month under review.

The formula used in the PPI calculation is the geometric modified Laspeyres.
