Summary

This is the monthly publication of the Producer Price Index (PPI) for the month of July 2023.

On annual basis:

- General Producer Price Index increased by 24.1 percent;
- Local Producer Price Index increased by 25.4 percent;
- Export Producer Price Index increased by 21.4 percent.

On monthly basis:

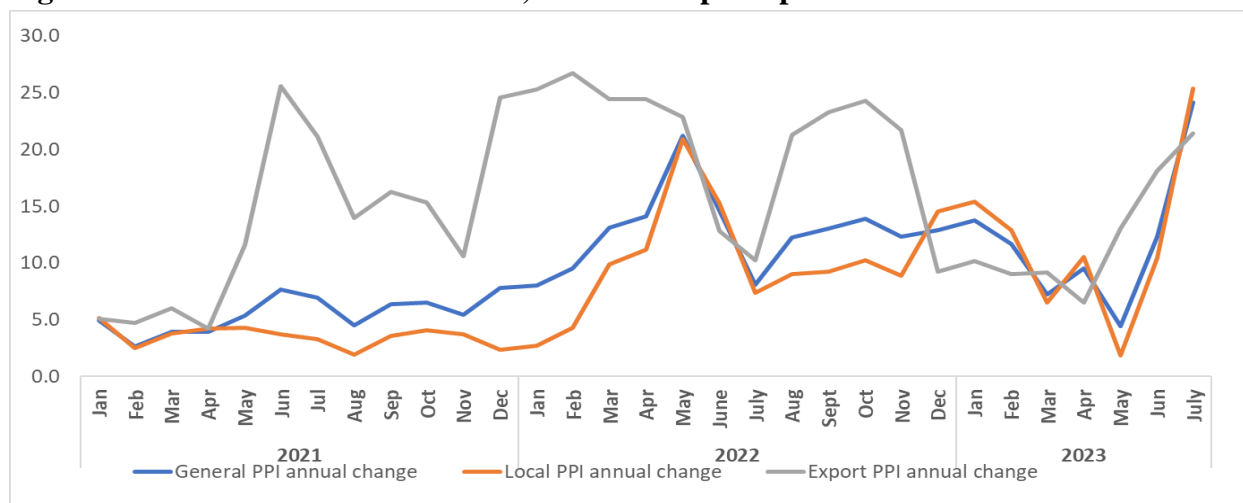
- General Producer Price Index increased by 4.6 percent;
- Local Producer Price Index increased by 5.9 percent;
- Export Producer Price Index increased by 1.3 percent.

1. Introduction

The Producer Price Index (PPI) measures the average change over time in prices received by domestic producers to produce their goods and services. The PPI for Rwanda is published on monthly basis.

It presents price changes for all combined products, products for local sales and that for exports.

It covers a sample of 114 establishments and 402 products spread countrywide, both in Kigali and provinces.

The Producer Price Index survey is conducted jointly with the National Bank of Rwanda. It covers mining, manufacturing, and energy.

2. General Producer Price Index

Table below presents the percentage changes on monthly and annual basis.

In July 2023, General PPI increased by 24.1 percent when compared to the same month of 2022. This is mainly due to an increase of 33.9 percent in prices of manufacturing activities and an increase of 1.6 percent in prices of mining.

Monthly general PPI increased by 4.6 percent. This is mainly due to an increase of 5.8 percent in prices of manufacturing activities.

3. Local Producer Price Index

The table below presents the percentage changes on monthly and annual basis.

Local PPI increased by 25.4 percent in July 2023 compared to the same month of 2022. This is due to an increase of 37.2 percent in prices of manufacturing activities.

Monthly local PPI increased by 5.9 percent. This is due to an increase of 7.7 percent in prices of manufacturing activities.

4. Export Producer Price Index

The table below presents the percentage changes on monthly and annual basis.

Export PPI increased by 21.4 percent in July 2023 compared to the same month of 2022. This is mainly due to an increase of 49.3 percent in prices of Coffee products, an increase of 5 percent in prices of Tea products and an increase of 1.6 percent in prices of mining. The prices of other chemical products increased by 37.8 percent.

Monthly export PPI increased by 1.3 percent. This is due to an increase of 2.2 percent in prices of Tea products, an increase of 1.1 percent in prices of Coffee products and an increase of 0.3 percent in prices of mining.

Technical note on PPI

The Producer Price Index (PPI) measures the average change over time in the prices received by domestic producers of goods and services which are output of production or enter in the production process.

NISR publishes PPI data for Mining, Manufacturing and Energy, and it is published monthly, about 4 weeks following the month under review.

The establishments are classified according to ISIC rev. 4; and the classification is determined by their main output.

The weights used in the PPI for Rwanda refer to the value of output (turnover without taxes) of establishments as reported in the 2011 Manpower survey collecting data for the year 2010, which constitutes the reference base period for the PPI calculation (December 2010).

The point of pricing is the establishment. The price is the selling price received by the producer for the selected product as it leaves the factory gate. In general, prices are collected each month from the selected establishment by considering the mid-point of each month of the month under review.

The formula used in the PPI calculation is the geometric modified Laspeyres
