SUMMARY

In the third quarter of 2017, Rwanda's total trade amounted to US\$ **725.09** million, an increase of **20.16** per cent over the third quarter of 2016. Exports totaled US\$ **170.66** million, imports totaled US\$ **482.86** million and re-exports were valued at US\$ **71.57** million.

Total domestic exports increased by 51.65 per cent during the period of the third quarter 2017 over the same quarter of 2016 (US\$ 170.66 million and US\$ 112.54 million respectively) and also by 22.56 per cent compared to the second quarter of 2017. Total imports of Rwanda increased by 9.89 per cent in the third quarter of 2017 when compared to the same quarter of 2016 (US\$ 482.86 million and US\$ 439.39 million respectively) and increased by 9.82 per cent over the second quarter of 2017. Re-exports from Rwanda increased by 38.92 per cent in the third quarter of 2017 over the same quarter of 2016 (US\$ 71.57 million and US\$ 51.52 million respectively) but decreased by 2.19 per cent compared to the second quarter of 2017.

The top five export destinations were: the United Arab Emirates, Switzerland, Kenya, the Democratic Republic of Congo and Singapore. Together, these five countries accounted for 75.57 per cent share of total value of domestic exports (US\$ 105.43 million).

The commodity groups with the largest export values were: "Other commodities & transactions, n.e.s" (US\$ 63.22 million), "Food and live animals" (US\$ 55.10 million), and "Crude materials, inedible, except fuels" (US\$ 38.43 million).

In terms of re-exports, the top five destinations in the third quarter of 2017 were: the Democratic Republic of Congo, Saudi Arabia, Burundi, Belgium, and Ethiopia. Democratic Republic of Congo accounted for 75.19 per cent share of Rwanda's total re-exports.

The most re-exported commodity group with the largest values was "Mineral fuels, lubricants and related materials" (US\$ 41.92 million), followed by "Food and live animals" (US\$ 10.91 million).

In terms of total imports, China, Uganda, Kenya, India, and Tanzania, United Republic of were the top five countries of origin of imports to Rwanda and totalized US\$ 244.93 million of imports bill (50.72% of the total value of imports).

The commodity groups with the largest values among the top imported products were: "Machinery and transport equipment" (US\$ 140.08 million), "Manufactured goods classified chiefly by material" (US\$ 90.63 million) and "Food and live animals" (US\$ 85.80 million).

INTRODUCTION

This Statistical Report of Formal External Trade in Goods covers the third quarter of 2017, the period running from July to September. It is produced by the External Trade Statistics Team of the Economic Statistics Department of the National Institute of Statistics of Rwanda (NISR).

One of the key mandate of the Economic Statistics Department is to compile, analyze and produce statistics and information on external trade sector. The data compiled by the Trade Statistics Team are provided by the Rwanda Revenue Authority (RRA), from the Customs Department, and then processed by NISR using EUROTRACE and MS Access database management systems (DBMS).

To collect and compile formal external trade statistics, NISR relies on the General Trade System under which the recorded aggregates include all goods entering or leaving the country's economic territory with the exception of simple transit trade.

Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses.

Exports cover domestic exports defined as goods of national origin; that is, goods produced in the exporting country and the nationalized goods.

Re-exports which are exported in the same conditions as imported or after undergoing minor operations which leave them essentially unchanged and include re-exports from customs bonded warehouses.

Partner country is the last known country of destination for exports and the country of origin for imports. This definition applies to all products with the exception of exports of coffee and tea, where the first known destination ports such as Mombasa and Dar Es Salaam are considered.

Valuation of imports and exports: Imports are valued on a CIF (Cost, Insurance and Freight) basis while exports are valued on a FoB (Free on Board) basis.

Classification of commodities: The data are categorized by partner country and the international standard classifications such as the Harmonized Commodity Description and Coding System (HS) and the Standard International Trade Classification (SITC), all linked to the national Customs Procedure Codes (CPCs).

Furthermore, the compilation of External Trade Statistics abides by the recommendations of the *International Merchandise Trade Statistics: Concepts and Definitions 2010* (IMTS 2010) of the United Nations Statistics Division (UNSD). Hence, the data for this report are compiled on **IMTS 2010** basis.

1. Rwanda's Formal External Trade in Goods

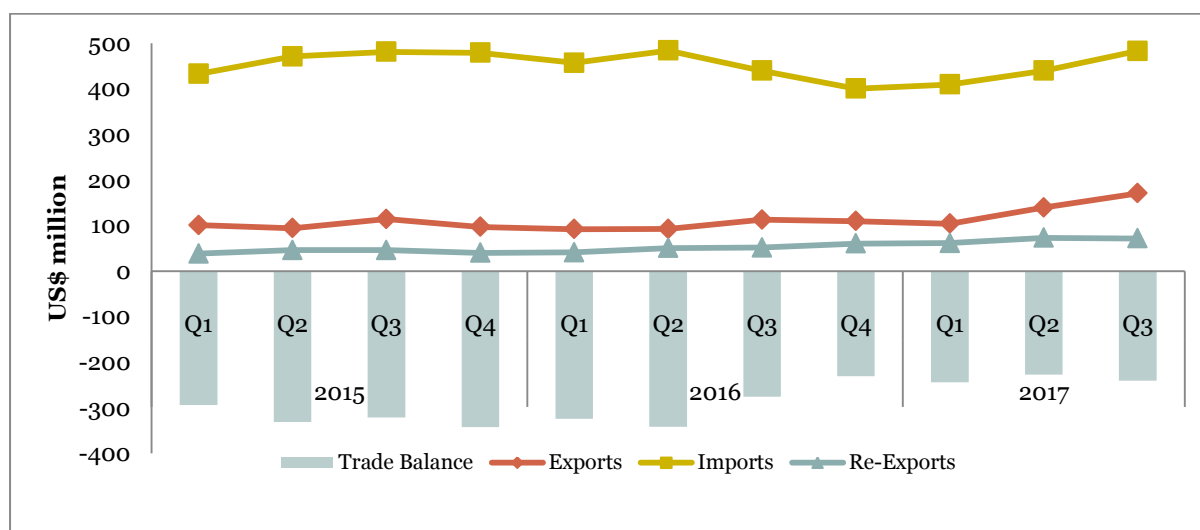
This section provides an overview of Rwanda's total trade in goods covering the period from 2015 to the third quarter of 2017, on a quarterly basis.

In the third quarter of 2017, Rwanda's total trade amounted to US\$ **725.09** million, an increase of **20.16** per cent over the third quarter of 2016 and an increase of **11.19** per cent from US\$ **652.09** million in the preceding quarter (second quarter of 2017).

Figure 1 summarizes the balance of Rwanda's formal trade in goods. Year-over-year, the deficit on traded goods decreased considerably by 12.60 per cent, from the same period in 2016.

Total imports of goods constitute 66.59 per cent of total trade in goods (US\$ 482.86 million), while domestic exports constituted 23.54 per cent (US\$ 170.66 million) and re-exports constituted 9.87 per cent (US\$ 71.57 million). For more detailed figures, see Appendix 6.1.

2. Domestic Exports

2.1. Overview

Compared to the second quarter of 2017, the third quarter of 2017 registered an increase in values of domestic exports of 22.56 per cent, with total domestic exports amounting to US\$ 170.66 million. Year-over-year, domestic exports' values increased by 51.65 per cent compared to the same quarter of 2016 (see Figure 1). This increase in total exports' values is largely explained by the increase in the values of some commodities like: "Other commodities & transactions, n.e.s" and "Manufactured goods classified chiefly by material" that increased by 130.50 per cent and 68.55 per cent respectively.

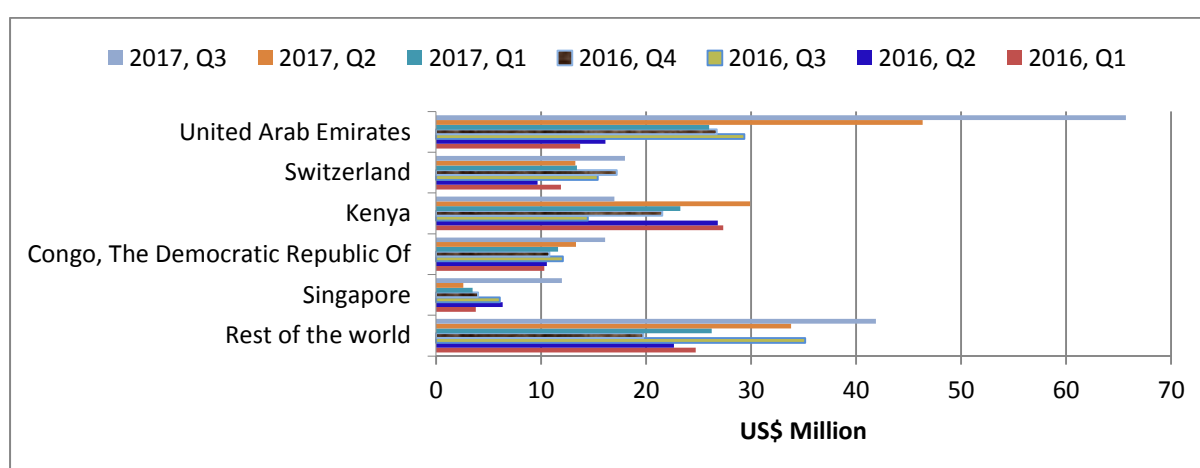
In the third quarter of 2017, the top three most valued exported commodities accounted for 91.84 per cent share of total domestic exports' values (see appendix 6.2b).

2.2. Rwanda's Export Markets

2.2.1. Trade Partners

Rwanda's key destination markets of exports during the third quarter of 2017 were, the United Arab Emirates (US\$ 65.68 million, 38.49 per cent share), Switzerland (US\$ 17.70 million, 10.37 per cent share), Kenya (US\$ 17.23 million, 10.10 per cent share), the Democratic Republic of Congo (US\$ 16.10 million, 9.43 per cent share) and Singapore (US\$ 12.26 million, 7.18 per cent share). Together, these five countries accounted for US\$ 128.97 million; that is 75.57 per cent share of total value of domestic exports in the third quarter of 2017. Figure 2 summarizes these figures from quarter one of 2016 up to the third quarter of 2017. For the top twenty domestic exports partners see appendix 6.5a

Main exports to the United Arab Emirates included “Other commodities & transactions, n.e.s.”; for Switzerland the main exports were “Crude materials, inedible, except fuels” while Exports to Kenya were dominated by the commodity group of “Food and live animals” for the Democratic Republic of Congo (DRC) we had “Food and live animals” and finally Singapore imported more of “Crude materials, inedible, except fuels” .

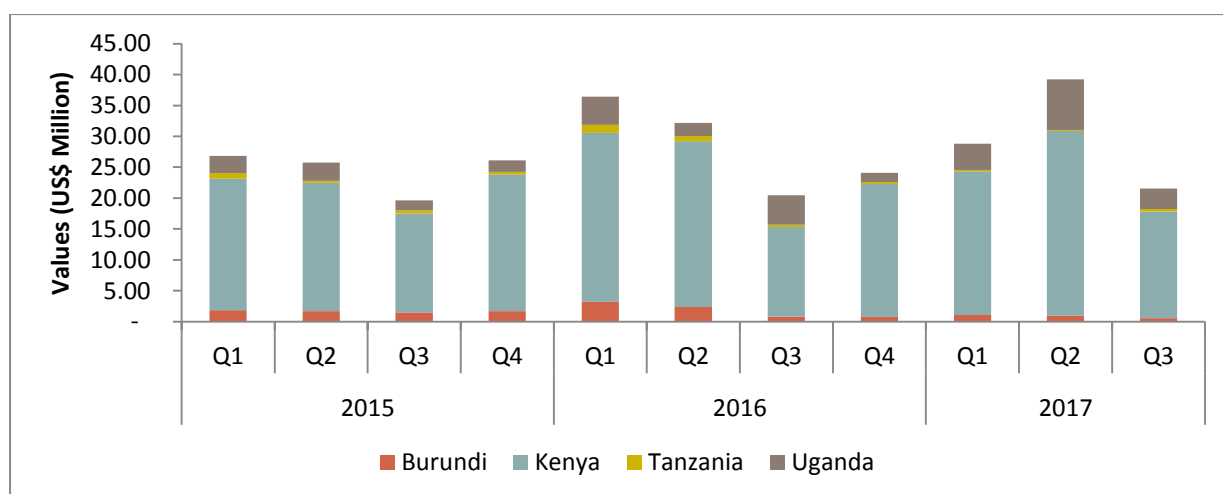
2.2.2. East African Community Partner States

Rwanda’s domestic exports of US\$ 21.53 million to the East African Community Partner States (EAC, South Sudan not included) in the third quarter of 2017 accounted for around 12.62 per cent of total domestic exports value see appendix 6.8b. Of these, about 80.03 per cent were destined to Kenya (US\$ 17.23 million). Figure 3 illustrates the total value of Rwanda’s exports to EAC Partner States from 2015 up to 2017Q3.

Domestic exports’ values to EAC Partner States decreased by 45.14 per cent in comparison with the second quarter of 2017 but increased by 5.27 per cent when compared to the same quarter of 2016.

In terms of EAC export shares, Uganda and Burundi followed Kenya (US\$ 17.23 million) with domestic exports from Rwanda valued at US\$ 3.27 million and US\$ 0.59 million, respectively.

3. Imports

3.1. Overview

The total value of imports in the third quarter of 2017 amounted to US\$ 482.86 million, an increase of 9.82 per cent compared to the second quarter of 2017 which amounted to US\$ 439.68 million and also a decrease of 9.89 per cent compared to the corresponding quarter of 2016 amounting US\$ 439.39 million (see Figure 1 above and appendix 6.1).

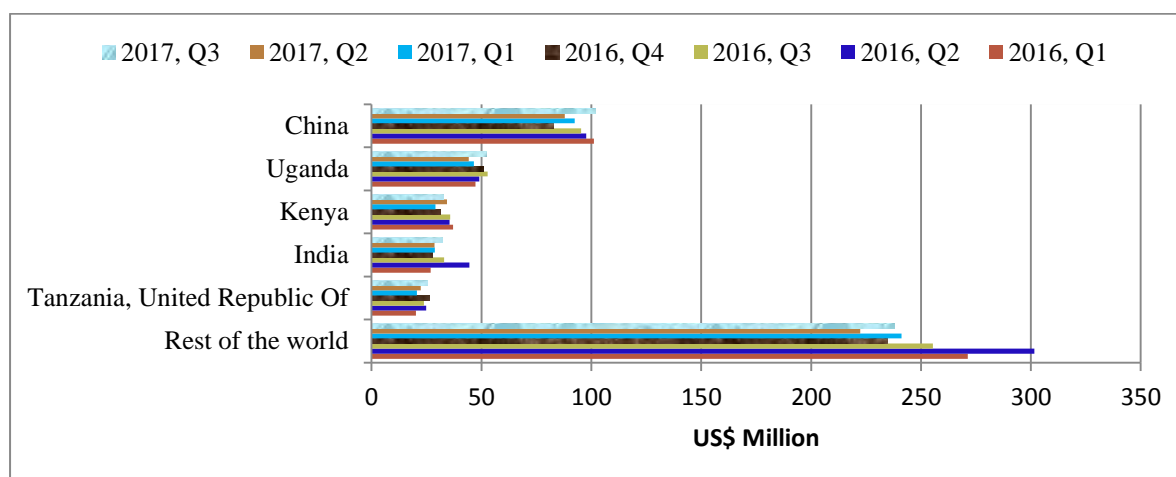
During the third quarter of 2017, the five most imported commodities in terms of USD values ranked from top to bottom were “Machinery and transport equipment”, “Manufactured goods classified chiefly by material”, “Food and live animals”; “Chemicals & related products, n.e.s.” and “Miscellaneous manufactured articles”.

3.2 Origin of the imports of Rwanda

3.2.1 Trade Partners

In the third quarter of 2017, the top five imports of Rwanda came from the following countries: China (US\$ 101.78 million), Uganda (US\$ 52.48 million), Kenya (US\$ 32.67 million), India (US\$ 32.48 million) and Tanzania, United Republic Of (US\$ 25.51 million). A more extensive table showing the top twenty partner countries in terms of imports is provided in Appendix 6.6a.

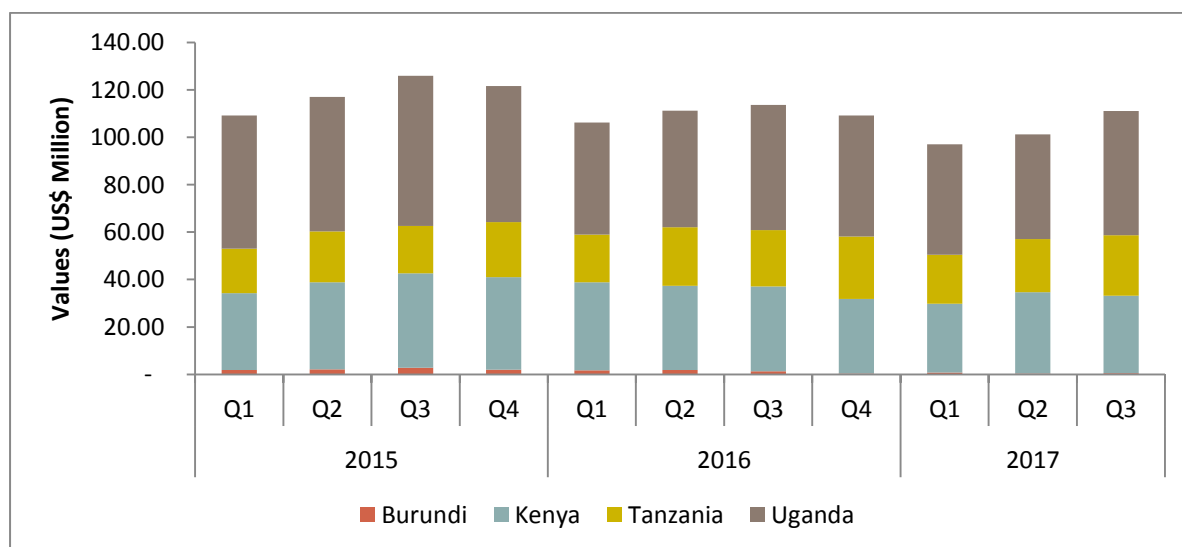
Rwanda’s main imports from China were “Machinery and transport equipment” and “Manufactured goods classified chiefly by material”. Imports from Uganda were mainly made of “Manufactured goods classified chiefly by material”, and “Food and live animals”. Kenya’s exports to Rwanda were “Chemicals & related products, n.e.s” and “Manufactured goods classified chiefly by material” For the same period, Rwanda imported from India “Chemicals & related products, n.e.s” and “Machinery and transport equipment”; while the Tanzania, United Republic of provided Rwanda with more of “Manufactured goods classified chiefly by material” and “Food and live animals”.

3.2.2 East African Community Partner States

In the third quarter of 2017, Rwanda’s imports from EAC Partner States (South Sudan not included) totaled US\$ 111.12 million; representing 23.01 per cent of all imported commodities (see Appendix 6.8a).

Figure 5 shows that Rwanda’s imports from EAC Partner States in the third quarter of 2017 mainly originated from Uganda and Kenya; 47.23 per cent and 29.40 per cent of total imports from EAC, respectively, representing together 76.63 per cent of total imports from EAC. Tanzania takes the third place with 22.96 per cent share of total imports from EAC and Burundi the last one with 0.41 per cent share. Rwanda’s imports from EAC Partner States decreased by 2.21 per cent when compared to the same quarter of 2016 (US\$ 113.62 million in the third quarter of 2016).

4. Re-exports

4.1. Overview

In the third quarter of 2017, Rwanda's re-exports amounted to US\$ 71.57 million, representing a decrease of 2.19 per cent over the second quarter of 2017 (from US\$ 73.17 million in the second quarter) and an increase of 38.92 per cent when compared to the same quarter of 2016 (US\$ 51.52 million).

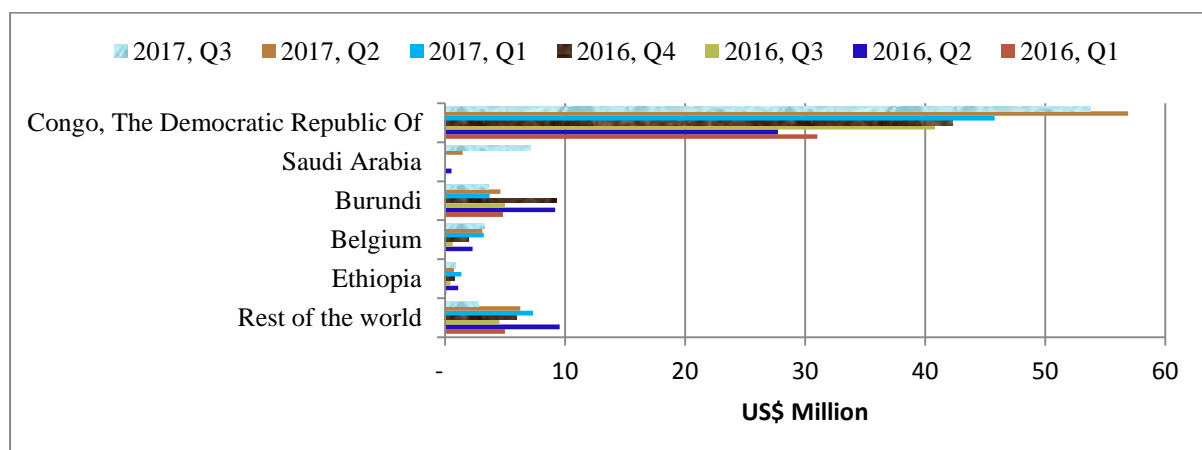
In the third quarter of 2017, the top three products re-exported by Rwanda accounted for around 83.22 per cent of total Rwanda's re-exports values. These are: "Mineral fuels, lubricants and related materials", which amounted to US\$ 41.92 million, registering an increase in value of 2.09 per cent over the second quarter of 2017 and an increase of 60.61 per cent compared to the third quarter of 2016; "Food and live animals", which amounted to US\$ 10.91 million registering a year-to-year increase of 57.10 per cent and a decrease of 12.44 per cent when compared with the second quarter of 2017; "Animals and vegetable oils, fats & waxes (up by 5.95 per cent year-over-year and also down by 4.29 per cent compared to the second quarter of 2017).

4.2. Rwanda's Re-export Markets

4.2.1. Trade Partners

The analysis of re-exports figures by country of destination for the third quarter of 2017 shows that African countries were the main buyers. Out of US\$ 71.57 million of re-exports value of Rwanda, the African countries accounted for 83.84 per cent of total re-exports. In the third quarter 2017, the Democratic Republic of Congo was the main destination, with 75.19 per cent share of Rwanda's total re-exports amounting to US\$ 53.81 million. Other important destinations of Rwanda's re-exports, ranked by per cent share, were Saudi Arabia (9.97 per cent), Burundi (5.08 per cent), Belgium (4.59 per cent), Kenya (3.86 per cent), and Ethiopia (1.27 per cent). Together, these five countries account for 96.10 per cent of the total value of Rwanda's re-exports (US\$ 68.77 million out of US\$ 71.57 million). Figure 6 below illustrates respective quarterly values per top five destinations of Rwanda's re-exports and the rest of the world.

Figure 6. Rwanda’s key re-export partners, 2016Q1-2017Q3

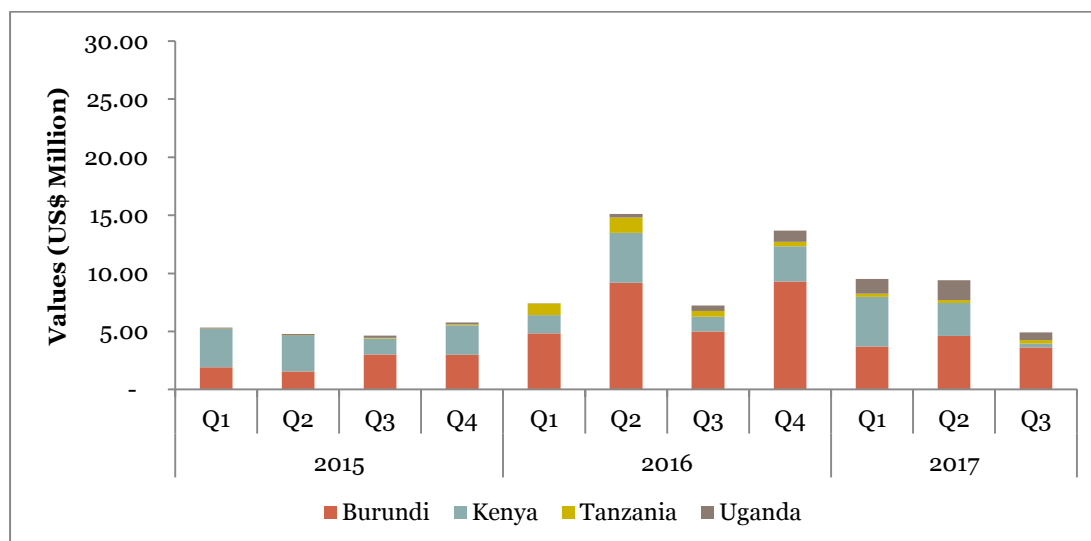

4.2.2. East African Community Partner States

Rwanda’s re-exports to EAC Partner States (South Sudan not included) decreased by 31.96 per cent in value terms during the third quarter of 2017 compared to the same quarter of 2016 (US\$ 7.24 million and US\$ 4.93 million, respectively) and also decreased by 47.62 per cent when compared to the second quarter of 2017 (US\$ 9.40 million and 4.93 million).

5. Trade with Selected Regional Economic Organizations

5.1. Common Market for Eastern and Southern Africa

During the third quarter of 2017, Rwanda's total trade with the Common Market for Eastern and Southern Africa (COMESA) Member States attained US\$ 207.70 million compared to US\$ 194.78 million registered in the same quarter of 2016 and US\$ 219.55 million registered in the second quarter of 2017.

Exports to COMESA Member States increased by around 8.51 per cent when compared to the same quarter of 2016 and decreased by 28.97 compared to the second quarter of 2017 (US\$ 38.21 million during the third quarter 2017, US\$ 35.21 million during the third quarter of 2016, and US\$ 53.80 million in the second quarter of 2017).

Imports from COMESA Member States increased by 0.15 per cent when compared to the same quarter of 2016 and also by 11.90 per cent when compared to the second quarter of 2017.

On the re-exports side, Rwanda registered revenues estimated at US\$ 59.33 million during the third quarter of 2017 from COMESA Member States; an increase of 19.70 per cent in value terms against the same quarter of 2016 (US\$ 49.57 million) but also a decrease of 11.85 per cent when compared to the second quarter of 2017 (US\$ 67.31 million).

Thus, a deficit in trade balance of US\$ 12.63 million has been registered during the third quarter of 2017 whereas a negative trade balance of US\$ 25.23 million has been registered during the third quarter of 2016. While, US\$ 22.65 million has been registered as a positive trade balance with COMESA Member States during the second quarter of 2017.

5.2. Communauté Economique des Pays de Grands Lacs

During the third quarter of 2017, total exports to Communauté Economique des Pays de Grands Lacs (CEPGL) Member States (Burundi and the Democratic Republic of Congo), including re-exports, totaled US\$ 74.14 million and total imports were US\$ 2.78 million. Therefore, the trade in goods surplus with CEPGL member states totaled US\$ 71.36 million compared to US\$ 55.14 million registered in the same quarter of 2016 and to US\$ 73.08 million in the second quarter of 2017.

5.3. Southern African Development Community

Rwanda's total trade with the Southern African Development Community (SADC) Member States totaled US\$ 135.17 million during the third quarter of 2017 compared to US\$ 106.69 million in the third quarter of 2016 and US\$ 119.21 million during the second quarter of 2017.

Year-over-year, domestic exports to the SADC increased by 25.69 per cent, from US\$ 13.56 million in the third quarter of 2016 to US\$ 17.05 million in the third quarter of 2017; while total imports increased by about 27.23 per cent, from US\$ 50.24 million to US\$ 63.93 million. Over the same period, re-exports increased by 26.37 per cent, from US\$ 42.89 million to US\$ 54.20 million.

Therefore, the trade in goods surplus with SADC totaled US\$ 7.32 million compared to a surplus of US\$ 6.20 million during the same quarter of 2016 and to the surplus of US\$ 22.86 million in the second quarter of 2017.

5.4. European Union

Trade in goods with the European Union (EU) in the third quarter of 2017 totaled US\$ 80.65 million against US\$ 68.37 million registered in the same quarter of 2016 and US\$ 76.36 million in the second quarter of 2017.

The quarterly exports to EU Member Countries increased by 28.46 per cent when compared to the same quarter of 2016 (US\$ 17.04 million against US\$ 13.27 million). The total value of imports from EU decreased by 10.49 per cent during the third quarter of 2017 over the same quarter of 2016 (US\$ 59.78 million against US\$ 54.11 million).

Re-exports to EU increased by 294.21 per cent during the third quarter of 2017 over the same quarter of 2016 (US\$ 3.83 million and US\$ 0.97 million respectively).

To sum, Rwanda's trade with EU registered a trade deficit of US\$ 38.91 million in the third quarter of 2017 and of US\$ 39.87 million in the third quarter of 2016.

5.5. Economic Community of West African States (ECOWAS)

During the third quarter of 2017, total exports to the Economic Community of West African States (ECOWAS) Member Countries, including re-exports, totalized US\$ 0.73 million and the total imports were US\$ 0.52 million. Therefore, the trade in goods deficit with ECOWAS Member States extended to US\$ 0.21 million from the trade deficit of US\$ 0.27 million in the same quarter of 2016.
