Well printed bids written in French or English language, properly bound and presented in four copies one which is the **original** and **three are the copies**, must reach the Central Secretariat of NISR, not later than 11th February 2013 at 10:00 am, hours prompt, local time, 08:00 GMT accompanied by a bid guarantee of Rwf 1,500,000 or the equivalent in a freely convertible currency issued by a reputable bank or a registered insurance company.
- 7. Bids will be opened in the presence of bidders or their representatives who choose to attend on the same day of 11th February 2013 at 10:30 hours prompt, local time, 08:30 GMT at the NISR's conference room.
