- 8. Bids will be opened in the presence of bidders or their representatives who choose to attend on the same day at 10:15 am, 08:15 GMT. The bids will remain valid for One Hundred and Twenty (120) days starting from the deadline of submission. The offers will be opened at the National Institute of Statistics of Rwanda conference room.
- 9. A company will be selected under the procedures described in the Bidding Document, in accordance with the New Procurement Law  $n^{\circ}05/2013$  of 13/02/2013 modifying and completing the Law  $n^{\circ}12/2007$  of 27/03/2007 on Public Procurement and Ministerial Order  $N^{O}$  001/08/10/MIN of 15/01/2008 establishing regulations on Public Procurement and Standard Bidding Documents.
- 10. The copies will be presented in an envelope called 'internal envelope'', mentioning the bidder's names and address. The later will be in turn, put in another envelope known as "external envelope" mentioning the reference number of the bids as well as the following mention:
  - "To be only opened in public session".
- 11. Delivery period and handing over the system with all equipments installed: Not more than Forty Five (45) calendar days after signing the contract and receiving a final notification letter.
